

# PRIVACY POLICY

## 1. Introduction

The **Centre for Joint Warfare Studies (CENJOWS)** ("we," "us," or "our") values the trust you place in us and recognizes the importance of secure transactions and information privacy. This Privacy Policy describes how CENJOWS collects, uses, shares, and protects personal information that you provide to us through our website **cenjows.in** (the "Site").

### 2.1. Personal Information

### 2.2. Non-Personal Information

When you visit our Site, our servers automatically record certain information sent by your web browser. This includes:

- IP address
- Browser type and operating system
- Date and time of your visit
- Pages viewed and time spent on the Site

### 3. How We Use Your Information

We use the information collected for the following purposes:

- **Communication:** To send you newsletters, issue briefs, and invitations to CENJOWS events.
- **Site Improvement:** To analyze site usage trends and improve the functionality and content of our website.
- **Security:** To detect and prevent fraudulent or unauthorized activity.

### 4. Third-Party Services and Google Maps

#### 4.1. Google Maps
