Introduction

This unique strategy downplays the offensive overtones that the Western countries have adopted, reflecting India's

distinct combination of its strategic needs and preserving its 'strategic autonomy'. The chapter presents India as a country that is navigating the conflict with a blend of pragmatism, diplomacy, humanitarian responsibility prevailing for peace and stability.

Mr Manoj Kumar discussed the significant solutions India needs to adopt in the backdrop of changing modern warfare tactics. The author emphasises the need for investment under the Atmanirbharta program in advanced areas such as electronic warfare, digitization, sensors, satellite communications and unmanned systems along with boosting conventional military capabilities. Neeraj Singh Manhas also discusses the implications of Russia-Ukraine war on India's National Security and the essential need for India to develop its domestic military and industrial capabilities with the aim to enhance innovation and self-reliance. Dhruv Ashok's examination of the hybrid nature of warfare in the Russia-Ukraine conflict is another addition in this section. He highlights how the conflict highlights crucial need for India's advanced military readiness and technological independence in the backdrop of hybrid warfare and the techniques employed by both Russia and Ukrainian military forces against each other.

In the concluding section, the chapter by Divya Rai and Harikesh Pratap Singh, discuss the geostrategic significance of the Indo-Pacific consisting of global maritime routes with key chokepoints like the Strait of Malacca and the South China Sea. These trade routes might be directly impacted by the global supply chains hampered by the Russia-Ukraine war.

The book does an excellent job of presenting multiple viewpoints, offering a balanced perspective on the conflict, providing profound insights into the complexities of modern warfare highlighting threats emerging from hybrid, cyber and psychological warfare. This books presents key themes and perspectives that shape our understanding of contemporary conflicts. A significant focus is placed on the changing nature of warfare, highlighting how hybrid and multi-domain strategies, such as cyber operations and unmanned systems, are redefining military engagements. Through this lens, the contributors illustrate how emerging technologies are transforming military strategies and operational dynamics.

India's diplomatic balancing act and non-interventionist approach is the prominent theme of the book emphasizing the nation's strategic autonomy amidst evolving global power dynamics. The contributors underscore the importance of selfreliance under the Atmanirbharta initiative in defence and diplomacy, as India navigates its relationships with major powers while safeguarding its national interests. India's approach is constrained and independent adopting the path of diplomacy that balances the 'fractured world order'. India's policy has been for moderate and practical, calling for peace through discussion and diplomacy rather than denouncing Russia directly, in contrast to several Western countries that have publicly criticized Russia. India abstained from voting against Russia in UN resolutions and even refrained from issuing statements on condemning Russia at the Summit for Peace in Ukraine held in Switzerland in the year 2024.

Additionally, the global shifts in power dynamics are assessed, inferring the ongoing conflict as a catalyst for the world transitioning toward a multipolar world. Nations like China, India, and Turkey are recalibrating their foreign policies, reflecting the broader implications of this war on the geopolitical shifts for the future.

In conclusion, Russia-Ukraine War: Strategic Conundrum is a significant addition to the study of geopolitics and modern warfare with changing techniques.
